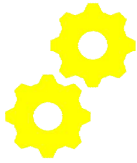

Litigation support – GSC case studies

- ⊗ Obtained Advance Ruling in a complicated case which prompted GST Council to amend the law
- ⊗ Deadline for special concession scheme (VCES) was missed. In the landmark judgment, GSC got favourable ruling from Tax
- ⊗ Filed GST appeals before First Appellate Authority with respect to transitional credit of Krishi Kalyan Cess and E-way bills
- ⊗ Turned the case in favour of a client where the prosecution was about to be launched
- ⊗ Various adjudications/first appeals argued successfully on tricky matters like:
 - ⊗ Construction services rendered to tenants against receipt of land development rights
 - ⊗ Management fees by asset reconstruction company to its Trusts
 - ⊗ Intellectual Property Rights
 - ⊗ Penalties in case of non-payment of indirect taxes like service tax, Central excise and VAT
 - ⊗ Limitation period in respect of refund claims of export of services
 - ⊗ Place of supply with respect to export of services
- ⊗ Reduction in VAT demands to the extent of almost 90% through appropriate interpretation of Law, meticulous and detailed working and appropriate representation before authorities

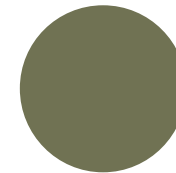

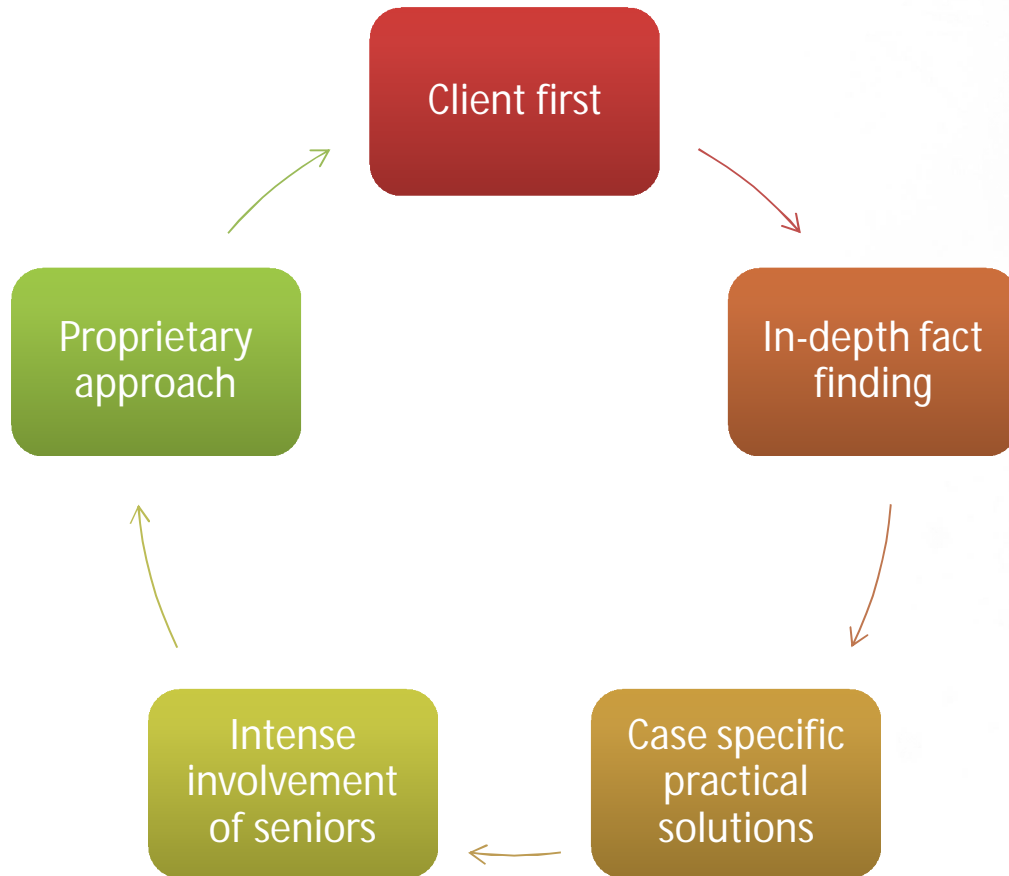
