
Key decisions taken by GST Council

- First voluntary phase to be rolled out from January 2020

3	Small Taxpayers (Aggregate turnover in previous FY <= 5 Crore))	Oct-19 to Dec-19 onwards	ANX-1	Quarterly in the month succeeding the quarter
			PMT-08 (in place of GSTR-3B)	Monthly to be filed in succeeding month

Notes:

- 1. New return system i.e. Form GST ANX-1 and ANX-2 would be available for trial for taxpayers between Jul-19 to Sept-19
- 2. Invoices may be uploaded on a continuous basis in Form GST ANX-1 from Oct-19 onwards. Form GST ANX-2 may be viewed simultaneously but no action would be allowed on such GST ANX-2
- 3. From Jan-20 onwards GSTR-3B would be completely phased out

Solar Power Generating System & Wind Turbines

- There was confusion on rate of GST applicable to Solar Power Generating System. Recently, Hon'ble Delhi High Court¹ had directed that the Writ Petition shall be placed for consideration before GST Council
- Therefore, now, in the present GST Council Meeting, it is directed that this industry specific issue shall be placed before Fitment Committee for recommendations
