However, considering that the due date for FY 2018-19 is on 31 December 2020 and since the annual return (GSTR-9) and reconciliation statement (GSTR-9C) for FY 2019-20 are not yet enabled on GSTN portal, it appears that the due date for GSTR-9 and GSTR-9C for FY 2019-20 may get extended.
